

# PROOFS OF RESIDENCE

To register to vote an applicant must provide proof of identity and proof of the address where living. The following types of proof are acceptable:

## EITHER

a document listed below with **CURRENT NAME AND CURRENT ADDRESS**:

- MN Driver's License, Learner's Permit, ID Card or receipt for one.
- Valid Student ID Card (if college has provided a student housing list to B.E.Co. Elections).
- Tribal ID containing name, address and signature.
- Prior Registration in the Same Precinct – Voter's previous name (i.e. name change) and/or address (i.e. moved within Precinct) is listed on the Polling Place Roster.
- Notice of Late Registration Letter, sent from B.E. Co. (Appropriate ID and/or proof of Residence documents have already been presented to and accepted by B.E.Co. Election Officials)
- Voucher, a Voter registered in the Precinct who can confirm the Applicant's address. (Voucher completes form on back of EDR Application and signs the oath in the presence of an Election Judge)
- Voucher – Residential Facility, an employee working in a Residential Facility located in the Precinct, who can confirm that the Applicant is a resident of that Facility.

## OR

a **PHOTO ID** document listed in **Column A AND** a **PROOF OF RESIDENCE** document listed in **Column B**
